Chevy Vertical Challenge Sweepstakes 2017-18 Official Rules

Sweepstakes Dates: The Chevy Vertical Challenge Sweepstakes 2017-18 ("Sweepstakes") begins at 12:00 a.m. Eastern Time ("ET") on 11/9/17 and ends at 11:59 p.m. ET on 4/20/18 (the "Promotion Period").

Winner Selection: A random drawing will be conducted by the Administrator on or about 4/30/18 to select one (1) potential Grand Prize winner from among all eligible entries received and combined in accordance with these Official Rules.
